


# The Palmetto Scrubber

## LEGISLATIVE UPDATE

H.3135, legislation sponsored by Rep. Murrell Smith and Rep. Brandon Newton was pre-filed in December 2016. This is the Bill that would allow the NCCT exam as an alternate method of certification. The state currently endorses and recognizes the NBSTSA national certification exam as the competency of choice. The Bill moved to the 3M committee which is the Committee on Medical, Military, and Public and Municipal Affairs. After the initial filing, the Bill did not move at all, as it is considered a "constituent request" bill, with no support in the other chambers. So, the Bill for

this year has been tabled and the legislative session is over.
